Stage 1 CILEX Graduate Qualification - option 1	Option 1 is for LLB/GDL graduates taking CPQ Civil Litigation or Criminal Litigation pathways. Graduates will also need to purchase the Stage 2 of the CILEX Graduate Qualification (CPQ Professional Stage) once they have completed the modules required for Stage 1 of the CGQ.	£735

Stage 1 CILEX Graduate Qualification - option 2	Option 2 is for LLB/GDL graduates taking CPQ Conveyancing, Wills and Probate, Family, Business and Employment Pathway.
