Question 1

Reference: Question relates to **Document 1** of the case study materials.

(a) Explain what further information you will want from Isla and Jaime before you prepare draft Wills for them.

(10 marks)

Marcus Wu wishes to ensure that everything is done to answer any questions that may arise in the future about the validity of Jaime's new Will.

- (b) Explain to Marcus the issues that may be raised concerning:
 - the capacity of Jaime to make a Will;
 - the intention of Jaime to make the Will you draft for him; and
 - the steps you will take to satisfy any questions that may arise in the future.

Question 2

Reference: Question relates to **Documents 2 and 3** of the case study materials.

(a) Explain to Charles and Daniel what the beneficial entitlement to Arthur's residuary estate will be according to the terms of his Will.

(9 marks)

(b) Explain to Charles and Daniel what duties in contract and in tort Black and Blue Solicitors would have owed when drafting and arranging for the execution of Arthur's Will.

(7 marks)

(c) Advise Charles and Daniel of the options available to each of them in connection with taking out a grant of representation to Arthur's estate.

(5 marks)

Assume it is now 25 September 2025. A Grant of Probate to Arthur's estate was issued to Charles and Daniel on 11 April 2025 and you are ready to distribute the residuary estate. Daniel is very reluctant to agree to any distribution other than to Arthur's legitimate issue.

- (d) Explain to both Charles and Daniel:
 - why, as executors and trustees, they cannot do this; and
 - any steps Grace might take if they do not include her in the distribution.

Question 3

Reference: Question relates to **Documents 4, 5 and 6** of the case study materials.

- (a) Advise Otka and Palmer:
 - how Niki's estate will be divided in principle; and
 - who is entitled to apply for a grant of representation to Niki's estate.

Note to candidates: no calculations are required for the above.

(b) Explain to Otka why and how she will be able to have 8 Fen Walk appropriated to her as part of her share of Niki's estate.

(6 marks)

For the purpose of the question below **only**, assume that 8 Fen Walk will be appropriated to Otka as part of her share of Niki's estate.

(c) Explain to Otka and Palmer, with reference to any exemptions and reliefs, why no Inheritance Tax will need to be paid as a result of Niki's death.

Question 4

(a) Explain to Xander who will be entitled to take out a grant of representation if he decides not to act as an executor.

(6 marks)

(b) Advise Xander whether it would be possible to deal with Vince's estate without taking out a grant.

(5 marks)

(c) Explain to Xander how he can avoid being responsible for Vince's debts if he does decide to act as executor.

(9 marks)
